- Clearing and Forwarding of International Transit cargoes
- Warehousing of International Transit cargoes
- Tallying and Cargo Superintendency
- Auxillary stevedoring services

The company was formed with the intention of facilitating and capitalizing on the resurgence and re-vitalisation of Maputo as a major regional port following substantial recent investment in the port and it's hinterland corridors. Mozport has within a short space of time become an established port agency company representing a number of major international shipowners and cargo interests. Main areas of activity relate to:

LINER AGENCY

Mozport is privileged to hold the liner agency representation of the world's largest refrigerated vessel operator, Messrs Seatrade Reefer Chartering of Antwerp

Seatrade is the major reefer operator calling at Maputo port and uplifts approximately 60 000 pallets of South African Citrus fruit in breakbulk form from Maputo each year, with Mozport handling approximately twenty port calls per annum in this regard.

TRAMP AGENCY

Mozport is active in tramp agency and regularly handles vessels on behalf of bulk and breakbulk owners. Main Commodities presently handled are bulk coal and bagged sugar exports. Management have previous extensive experience in handling cargoes as diverse as ores, livestock, timber, steels and project cargoes, as well as passenger and Naval vessels, and tug/barge operations.

Mozport regularly acts as owners protective agents and is able to arrange off port limits services if required

CLEARING AND FORWARDING

The company is able to handle any road/rail /sea/air consignments, both import and export and provide a seamless overall service to & from Free on Board/Free Out to point of origin , be it local or overborder cargo. Where necessary warehousing , transport ,handling and tallying is arranged and managed on behalf of clients. The company will handle approximately 80000 metric tonnes of freight cargo in this manner during the present year and represents a number of South African and International clients in this regard. No matter how large or small the consignment size is, Mozport will ensure that it is successfully handled in a cost effective and professional manner.

TALLYING SERVICES

Mozport operates it's own tally division and is contracted to tally fruit, sugar, packing of containers and other import/export cargoes regularly . The company employs full time uniformed clerks who are well experienced and properly supervised.

Mozport is able to perform full tally functions to clients for all cargo types, both inside and outside the port area at short notice .

SUPERVISION

Mozport presently provides quality control and supervision of fruit exports and have specially trained staff who operate modern scanning equipment and act to stringent requirements in ensuring the safe shipment of value products. In addition we provide Supercargo services to shipowners and operators who need vessels turned around promptly and efficiently. Please contact us for assistance.

PROJECTS

Mozport management and directors have previously been involved in the handling of project cargoes of all types, including the agency and port logistics co-ordination of the largest project cargo operation to date at Maputo port involving the discharge of 100000mt of coated steel pipes during 2000-2002. Our staff are able to assist with the co-ordination of heavy transport , police escorts and officialdom.

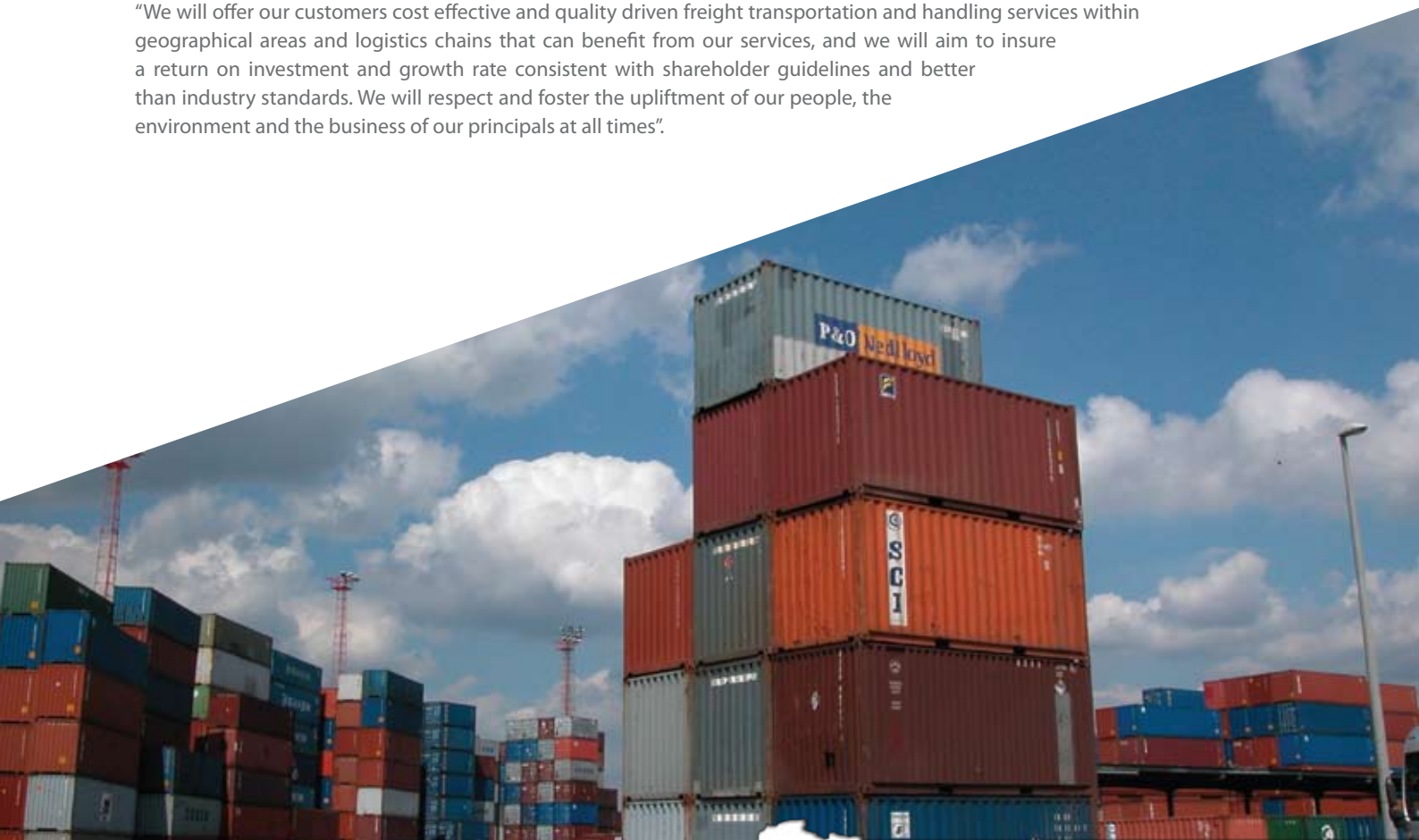
The company is managed by Mr Elias Ismael, a local Mocambican with over 15 years shipping experience and whom reports to the Board of Directors.
